50% reduction in malaria deaths

10.6 million lives saved

1.7 billion malaria cases prevented




The RBM Partnership has helped countries navigate evolving challenges, including COVID-19, and helped mobilize historic funding for the fight against malaria





2022 has already been a busy year for the RBM Partnership




The RBM Partnership Board adopted decisions to strengthen representation of and accountability to our community

- The RBM Partnership Board initiated a governance review in May 2022 in response to growing calls for the partnership to reflect a changing global health landscape.
- The Board adopted four decisions at its meeting on October 25th to reorganize itself, enabling increased engagement with malaria-affected communities and other segments of the malaria community.
- The new Board will be put in place by Q2 2023
- While the Board transition is underway, the Secretariat and Partnership and will continue to execute on their responsibilities.

Governance restructuring has been a consultative process that will culminate by Q2 2023

Hybrid Board Composition & Constituency Representation

- The Board adopted a new hybrid Board structure, with a combination of representational constituency-based and independent seats.
- The hybrid structure is expected to allow the Board to leverage key perspectives from across the global malaria community while also ensuring the Board has access to expertise and independent voices.

Hybrid Board Composition & Constituency Representation

- Allocation of seats will ensure proportional geographic, based on epidemiological burden and complexity, and sector representation on the Board.
- Across all constituency segments, existing organizations will be prioritized to act as support structures for facilitating representative nominations.
- Consultations with AU are ongoing to determine appropriate support structures for Africa.

Board Transition and Bye-Laws Adoption

- A Transition Oversight Committee (TOC) is being formed to oversee the process of transitioning to new governance structures.
- Under the guidance of the TOC, the Bye-Laws will be updated to reflect adopted changes.
- The TOC commits to frequent communications as constituency representation details unfold.

Looking ahead

- Governance review process
 - Updated Bye-laws will be considered at the next Board meeting at the end of November
 - Constituency groups will receive more information about Board seats and the nomination process in the coming weeks
 - Looking forward to welcoming a new Board in Q1/Q2 2023
